RELEASE, WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

IN CONSIDERATION of being permitted to enter for any purpose the sporting clays and hunting facilities (the "Facilities") operated by SELWOOD FARM, INC. ("SELWOOD"), THE UNDERSIGNED, individually and on behalf of the undersigned's personal representatives, heirs, and next of kin (individually and collectively, the "Undersigned"), acknowledges, agrees and represents that the Undersigned:

1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE SELWOOD, shooters, guides, trappers, any other person on the Facilities, owners and lessees of premises used in operating the Facilities, and each of them, their officers, directors, shareholders, employees, agents, successors, assigns, heirs, next of kin and personal representatives (all herein referred to as "Releasees") from all liability to the Undersigned for any and all loss, damage or expense, and any claim, demand or suit therefor on account of injury to the person or property or resulting in death of the Undersigned, whether caused by the negligence of Releasees or otherwise, while the Undersigned is in or upon the Facilities, and/or, competing in, guiding, officiating, observing, working for, or for any other purpose participating in shooting or hunting activities on the Facilities;

2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees and each of them from any loss, liability, damage, cost or expense they may incur due to the presence of the Undersigned in or upon the Facilities or in any way competing in, guiding, officiating, observing, working for, or for any other purpose participating in shooting or hunting activities on the Facilities, whether caused by the negligence of Releasees or otherwise;

3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE (includes but not limited to Selwood guns, golf carts and furnishings) due to the negligence of Releasees or otherwise while in or upon the Facilities and/or while competing in, guiding, officiating, observing, working for, or for any other purpose participating in shooting or hunting activities on the Facilities; and

4. HAS READ, UNDERSTOOD AND HEREBY AGREES TO ABIDE BY THE RULES LISTED ON THE REVERSE HEREOF. (or page 2)

5. HEREBY AGREES THAT THIS RELEASE, WAIVER OF LIABILITY AND INDEMNITY AGREEMENT SHALL BE CONTINUING.

6. HEREBY AGREES THAT NO ORAL REPRESENTATIONS, STATEMENT OR INDUCEMENTS APART FROM THIS WRITTEN AGREEMENT HAVE BEEN MADE.

THE UNDERSIGNED UNDERSTANDS THE INHERENT RISKS AND DANGERS INVOLVED IN SHOOTING CLAY TARGETS AND HUNTING, AND HAS READ, UNDERSTOOD AND VOLUNTARILY SIGNS THIS RELEASE, WAIVER OF LIABILITY AND INDEMNITY AGREEMENT.

WARNING: Some areas of the Facilities are subject to occasional minor shotfall from other areas. Where these areas are concerned, persons on the Facilities may notice shotfall. There is also the possibility of pellet deflection off of trees, targets, and other solid objects. Likewise, pieces of clay targets (and even whole targets) may fall near or even strike persons on the Facilities.

RULES

1. Protective shooting glasses and ear protection must be worn at all times by all persons on the Facilities.
2. The largest shot size permitted is #7 ½.
3. While waiting your turn to shoot, be certain that your position is safely behind the shooter, clear of his field of vision.
4. The only time a gun will be loaded is when the shooter is actually on-station prepared to call for target. Guns should be loaded only with the muzzle pointed in a safe direction. At all other times the gun will be unloaded and placed in a rack or unloaded and carried with the action open. There are **NO EXCEPTIONS** to this rule, except as it relates to hunting as set forth in rule 11 below.
5. At no time will a shooter load more than two shells in a gun, except with hunting.
6. Before leaving the station, shooters will ensure that the gun is unloaded and the action is open. Keep muzzle pointed down range when gun is loaded or when ejecting empties or unloading. In case of malfunction, keep gun pointed down range until clear.
7. Practice swings from behind any stations are not allowed.
8. Use of alcoholic beverages is strictly prohibited.
9. Keep the muzzle of your gun pointed away from other persons on the Facilities at all times.
10. All spent hulls on the ground are the property of SELWOOD.
11. This rule applies to hunting only. Special attention to safety is required when hunting since you will be in close quarters with other hunters, guides and dogs. **DO NOT LOAD YOUR GUN UNTIL TOLD TO DO SO BY YOUR GUIDE.** Keep the gun safety **ON** until you are ready to shoot. Flushed birds have unpredictable flight paths. Make sure you and other hunters agree on your zones of fire. Only take shots in your zone. When in doubt, pass up a shot that could endanger another person or dog. Follow all instructions given by the guide, he is in control of the hunt.
